- Junior & Year 11 Statistics (started) with Fraser Farm
- We care about students, Mana, what do students want to learn about, help students to find it purposeful.
- Goal- Numeracy
- Mathematics has no extra support like in literacy, we do not have that support, would be nice to. As some students are so off the mark and are not ready for Year 11.
- Year 9 & Year 10 build up their numeracy profile, new standards don't have 20 credits.

- New Curriculum Teach first, assess later.
- Personally, Emma likes the new standards, allows more freedom, flexible, what is needed for our students.
- Test is through computer a lot of kids may not have a computer, or do not understand how to use one/software. Lack of funding / to support. School is not well resourced.
- Very excited to start new curriculum.
- Worried about the pressure from the top (Ministry)
- Paul: As a board what can we do to help? Emma: Pressure from the Ministry, doing changes too fast, not enough support, was lucky to go out and learn the new standards and then teach the South Island schools. Please ask Ministry to slow down, having an impact on our staff.
- Graham: Under sourced or understaffed? Emma: Both
- Kirsten: Congratulations on getting into the pilot, will be great community wise to teach others. Emma: Very lucky - Currently supporting primary & intermediate with mathematical common language & common glossary, across all of the schools. Kahui Ako.
- Graham: Student inputs on Math's? Emma: Communication, getting students to reflect on our classes.
- Kirsti: Does the frustration flow to the children. Emma: Lucky, that all my staff are respondent to the students.
- Emma: We are Teachers, we love what we do.
